
- c. To help and render relief to the poor deserving students studying in schools and colleges
- d. To establish, maintain and support or assist in establishment of libraries and reading rooms
- e. To establish the residential school and to start the free hostel for the benefit of poor students
- f. To carry on any work directly or indirectly promoting the object of the trust or calculated to do so or as may be incidental or conducive to attainment of the above objects
- g. To purchase lands, sites, building and property and other moveable and immovable assets of the trust
- h. To lease, mortgage the trust building or property for the benefit of the trust
- i. To offer/sponsor and grant scholarships to the needy and deserving students, irrespective of religion caste, creed or community in trust or other educational institutions
- j. To get collaboration or to enter into agrément with foreign schools, colleges or universities to offer their courses.
- k. To receive donations of any kind from societies, trusts, individual persons, institutions, companies or any other organizations
- l. To open and operate accounts by the President of the trust, in banks, post offices and other financial institutions. Also to borrow loans, funds over draft cash credit, term loans from the banks, financial institutions and other institutions or persons as the board of trustees deem fit and president will have the power to sign the documents and give security of trust properties while borrowing
- m. To undertake and to do any other work of similar nature aforesaid and carry out any other work to promote the aforesaid objectives

3. TRUST FUNDS - The author of the trust hereby sets apart a sum of Rs. 1000/- (Rupees One Thousand only) at the Nationalized Bank in the trust as nucleus of the purpose of the trust and constitute himself as Founder Trustee and the President (Author) will be solely administer the trust with the co-operation of the other trustees

3. (a) In addition to the Rs. 1000/- set apart by author of the trust at the Nationalized Bank, following trustees namely Roopa Ramaiah, Nagarathna R and Roopa Paramesha have invested 44%, 41% and 15% respectively towards trust investment.

4. The bank account shall be solely operated by the president of the trust. In the absence of the trust president or otherwise the board of trustees shall authorize the secretary along with the treasurer shall jointly operate the said bank account

5. (a) The secretary and treasurer should prepare receipts and payments account every month and place before quarterly trust meeting and get approvals. After the close of official year, the annual accounts should be prepared and audited by the chartered accountant

6. The president of the trust may at any time or times, co-opt or nominate not more than 12 trustees. On the co-option of the trustees, the president of the trust shall continue to administer the trust

7. The following are the trustees, nominated by the President (Author) of the trust, who shall also be called the president of the institution, who runs under the administration of the trust. The President shall be the chief controlling authority.

12. The president shall guide and direct the Secretary and Joint-Secretary, in regard to the administration of the trust and the treasurer to that of the trust funds

13. The President shall preside over all the meetings of the board of trustees and in his absence the trustees present shall elect one from amongst the members as President of the meeting. The Secretary shall be in charge of and responsible for the safe custody of all records of the trust. The Secretary shall comply with and carry on all the office correspondence and instructions given from time to time by the President of the board of trustees

14. (a) That subject to overall supervision and control, over the trust, the secretary shall be the executive officer of the trust and shall be responsible for the smooth working of the trusts in accordance with the rules. He or She be in charge of office work and maintain all records and registers and also responsible for the due implementation of the resolution passed by the board of trustees. 

- b. To purchase, take over on the lease or otherwise, acquire, by way of exchange, sell, improve, develop, manage, lease out dispose of or turn into account or otherwise deal with the assets for the purpose of the trust
- c. To borrow for the purpose of the trust on the personal credit of the trust with or without charge and responsibility upon the assets of the trust
- d. To invest from time to time the trust funds in such securities, shares, stocks, bank deposits, debentures, and government securities and in such manner as the trustees deem proper
- e. To receive, recollect or realize or cause collection or realization of the all interest, dividends, bonus of premium to accrue due on all or any shares, stocks, funds, securities, debentures or deeds of documents of like nature

- g. To sell and convert in to money all or any of the shares, stocks, debentures and other securities


